Suspension Functionality

We are very excited to inform you that the new tracking system for junior Code of Conduct Violation reports is now active. This system has been in development for several years and will allow us to centralize the reporting and tracking of code violations in one location on TennisLink. Moreover, the system is designed to allow tournament staff (tournament director or tournament referee) to record the violations during the tournament and email a violation report directly to the player. Even better, the very slow process of recording violations on paper and then mailing them to another location for record keeping is eliminated.

As you scroll down the page, you will see on the right-hand side an **Administration** box, and in that box is a link to input Player Violations, as seen below:

Select **Player Violations**, and the following page will come up. In the **“Add Player Violation Search”**, you will enter the Tournament ID and either USTA # or First & Last Name of the player who was issued the violation and select Search.

The Player’s information will show up as follows, and you’ll click on their USTA Number to move forward to the Code Violation Form.

The below information will show up for the player and your tournament will come up on the Dropdown Menu with your dates, Referee Name, etc.

You will then input the Code of Conduct information: Date, Division, Draw (Singles, Doubles, Consolation), Code (Warning, Point, Game, Default), and select the Violation (Ball Abuse, Default No-Show, etc.). The correct number of Violation points will populate, and you will have the opportunity to input Comments about the situation. It is encouraged that a detailed description is provided in the Comments section in the event the player accumulates enough suspension points to be suspended and appeals the suspension.
