

## **Referee Mentor Program (For previously certified official only)**

An official may be certified as a Provisional Referee by taking the appropriate USTA tests and attending the USTA Officials and USTA Referee schools. However, before a Provisional Umpire can be added to the list maintained by NCTA of those approved to referee NCTA-sanctioned tournaments they must complete a referee mentoring program.

That program includes working a minimum of one complete tournament as a volunteer deputy referee under a highly-experienced referee designated as a mentor by the NCTA Officials Committee. That work will expose the provisional referee to all the aspects of refereeing, including, but not limited to:

- preparation of officiating budget
- reviewing entries
- seeding
- making the draw
- scheduling
- TDM
- officials recruitment and hiring
- roving officiating
- completion of paperwork at the close of the tournament.

After completion of the tournament the referee-mentor will complete an *evaluation form (see next page)* for the provisional referee and recommend to the NCTA Officials Committee whether the provisional referee should be added to the list of referees approved for NCTA-sanctioned events, or if additional training/mentoring is needed, and if so, in what areas.
